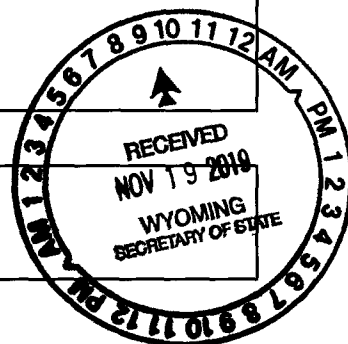

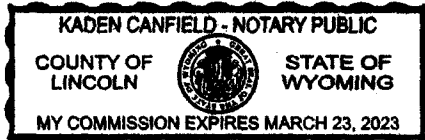

- **Filing Fee: \$100.00** Make check or money order payable to Wyoming Secretary of State.
- One **originally signed and notarized** filing must be submitted.
- Registration is effective for a term of ten years and is renewable. The renewal may not be filed more than six months prior to the expiration.
- Renewal forms are mailed by the office of the Secretary of State to registrants whose trade name is up for renewal. Trade name renewal fee is \$50.00.
